Evans Walker read a letter from Harlem Township about their annual Toys for Tots involvement Albert "Harley" Johnson made a motion that RYC donate \$100 to the Toys for Tots/Harlem Township program, seconded by Preston Aylesworth and approved unanimously.

Commodore Evans Walker held an "October" "Annual Meeting" so some changes to the by-laws could be introduced and officer elections to take place.

As proposed by motion made by Allen Penticoff, then seconded by (didn't get that - I think Preston or Harley). The motion was made to amend the by-laws to change the timing of the election of officers to November and them to take office in January to coincide with the calendar year. Commodore Walker adjourned the "October meeting" and opened the November Meeting with Ruth Penticoff as Commodore. Eric Mueller was absent, Allen Penticoff read the purser's report.

Amendment to the By-Laws of Rockford Yacht Club

Rationale for change. For a very long time the club has held it's election of new officers in October at the official "annual meeting." The new officers then take their positions at the following meeting in November. While we are now having meetings on alternating odd months, the election does not align properly with what is happening. But more so is the need for change from having new officers take over right at the busiest time of the club year - just when dues are collected and the Christmas Party and all it entails is taking place. It would seem more friendly to have experienced officers take care of this year end business and start fresh with the new officers in January when most of the hub-bub is past. This may make it easier to recruit nominees for positions as well. Second part, changing our "fiscal year" to that of the calendar year. It has always been somewhat confusing in collecting dues and a few other things in having a fiscal year that does not run concurrent with the calendar. This would straighten that out.

To effect these changes the following amendments are proposed; to be ratified by 2/3rds of the membership present at a meeting following 32 days notice of the proposed amendments. (We'll vote on this in Jan. 19, 2009)

Article V. Officers Section 4.

is amended to read:

Officers shall be elected at the annual meeting in November, and serve a one-year term from January 1 to December 31.

Article VIII. Meetings Section 1.- C.

is amended to read:

The Annual Meeting of the Club shall be the regular meeting in November of each year. The active members present at the Annual Meeting shall constitute a quorum. A simple majority of said quorum is required for passage of any action unless otherwise covered by the By-Laws.

Article VIII. Meetings Section 1. - D.

is amended to read:

Fiscal year will be from January 1 to December 31.
